Format/Additional Information

1. Except for events #18, 19, 25, 26 and 27 players must be current USATT members or must join (see membership information on entry portion). Memberships can be purchased at the tournament. For events #19 (U-3800 Doubles) and #27 (Handicap) players must have a current USATT rating (within 3 years).
2. Recreational (#25) is for players who have never been rated.
3. On site registration is permitted for events #25, 26 and 27 only.
4. *51 Point Handicap (#27) it is unrated, single elimination and open only to rated players. Players rated 2300 or over have free entry in this event.
5. Event #26 is a team event for employees who work for the same corporation, government entity (such as police officers or firemen), any employer, etc. Teams are two players (rated or unrated players) and a team match will be A v. X, B v. Y, doubles, A v. Y, and B v. X. Companies may field more than one team.
6. All matches will be 3 of 5 games, except in Open Doubles and elimination rounds in Open Singles which will be 4 of 7.
7. Format will be RR groups of four with top player advancing in all events, except Open Doubles and Handicap will be single elimination.
8. Unrated players may enter any event **BUT** will not advance from their round robin in events #2 through #17.
9. Depending on entries, top seeded players in Open singles may be placed directly into the elimination round.
10. All age events cutoffs will be 9/18/15.
11. Any event starting 3:30 PM or later on Saturday **MAY** carryover elimination rounds to Sunday.
12. Event #24 is a hardbat event. Hardbat rules are listed at www.hardbat.com. Matches are 2/3 games to 21.
13. All players must pay \$5 registration fee and \$10 tournament processing fee, except players entering in events #18, 19, 25, 26 and 27 only and no other events do not pay \$10 tournament processing fee.
14. Players may not enter more than one event with the same starting time. **Default time is start time.**
15. Tournament management may modify, combine, or cancel events, limit total entries or total entries by event.
16. All USATT rules will be enforced. Boosters or glue with VOC's are not permitted. No prizes awarded for splits, dumps, defaults, or no-shows. No white shirts, shorts or skirts.
17. Ratings as of 8/21/15 will be used for event eligibility; seeding will be based upon latest available ratings.
18. No refunds after entry deadline.
