- Team playing order shall be M Corbillon Cup format: A v Y, B v X, Doubles, A v X, B v Y, .
- The Tournament Committee reserves the right to cancel any event due to insufficient entries.

- Current ITTF laws and regulations will be in effect.
- All rackets must be one side black and one side red with ITTF approved coverings.
- Street clothes, tracksuit or any part thereof shall not be worn during play except by special permission of the Referee (see ITTF regulations).
