Entry Information: The entry deadline is **Wednesday, November 30**. Late entries and those without payment will not be accepted. Phone entries will be accepted, but spots in limited entry events cannot be guaranteed until payment has been received. Cancellations within 48 hours of the start of the tournament will be awarded full refunds. Cancellations after this time, including no-shows, will be handled at the discretion of the Tournament Director. Current USATT membership is required for all singles events (see fee schedule that follows); alternatively the Tournament Pass can be purchased.
